

Florida Saltwater Fishing Record Application

The Florida Fish and Wildlife Conservation Commission (FWC) maintains state records for marine fishes caught in Florida state waters or in federal waters extending directly outward of Florida state waters between latitude 30.71 in the Atlantic and longitude -87.52 in the Gulf of Mexico. Records are maintained for the heaviest fish in all tackle, youth and fly-fishing categories, and the longest fish for several species in the all-tackle and youth categories. Catches must follow Florida's fishing regulations, the Catch a Florida Memory - Saltwater Angler Recognition Program: General Angling Rules, and the Florida Saltwater Fishing Records Program Rules.

To qualify for a record, **photographs must be submitted** clearly showing the weight displayed on a **certified scale** for a weight record, length **over** a measuring device for a length record, gear used to make the catch, the angler with their catch and various views of the fish for identification purposes. Species that are difficult to identify must be confirmed by a qualified fisheries biologist. The angler's signature on a completed application form **must be witnessed by a notary**. Anglers must be **age 15 or under** at time of catch to qualify for a youth record. HOW TO MEASURE FISH FOR LENGTH REQUIREMENT

TOTAL LENGTH

Total Length is measured from the most forward point of the head, with the **mouth closed**, to the farthest tip of the tail with the tail compressed or squeezed, while the fish is lying on its side (See Figure A). For fish that have "ragged-edge" type filaments, these "pieces" of the tail should be included in the measurement of total length and measured to the "farthest tip of the tail" in the definition for total length (See Figure B).

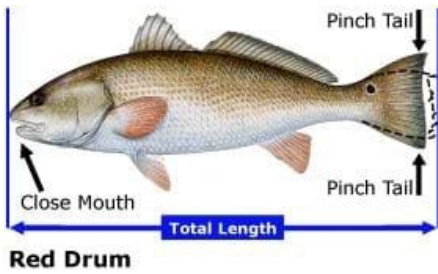

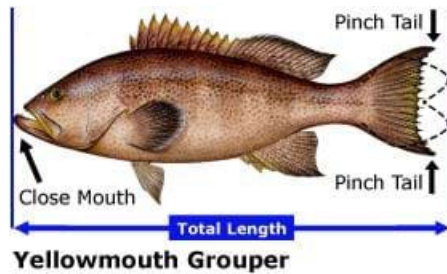

FORK LENGTH

Fish regulated by fork length are measured from the tip of the jaw or tip of the snout with closed mouth to the center of the fork in the tail (See Figures C and D).

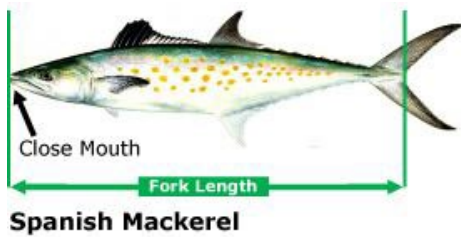

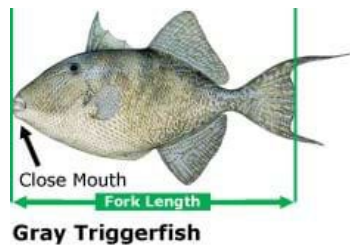
